ABOUT COLORADO CREATIVE INDUSTRIES

Established to capitalize on the immense potential for our creative sector to enhance economic growth in Colorado, the mission of Colorado Creative Industries is to promote, support and expand the creative industries to drive Colorado's economy, grow jobs and enhance our quality of life.

ABOUT CBCA ADVANCING CREATIVES INTENSIVE (ACI)

<u>Colorado Business Committee for the Arts</u> (CBCA) launched the Advancing Creatives Intensive (ACI) in spring 2022. The ACI curriculum is designed to be a launch pad for creative professionals who want to articulate and take practical steps to achieve their business goals. ACI is focused on business growth and planning for artistic careers, as well as building business skills like marketing and financial management. ACI enables artists of all disciplines to see their work through an entrepreneurial lens and employ tools to organize, plan and sustain their creative career.

By completing the program, ACI participants are eligible to apply for a limited number of Career Advancement Grants, funded by Colorado Creative Industries, to support their ongoing work.

ABOUT ACI CAREER ADVANCEMENT GRANT

This grant award supports Colorado creative entrepreneurs and artists to advance career growth and enhance their commercial creative business. The goal of the funding is to assist awardees in achieving tangible business benefits such as increased revenue, reaching new audiences/markets, or improved management practices. This award is intended to support an existing creative business or professional career. The following list, while not inclusive of all activities for which support may be used, illustrates some possible areas of support:

- Purchase of equipment and materials to expand or improve an applicant's arts business and/or creative production
- Acquisition or upgraded technology related to business practices (e.g., online sales systems, website functionality, digital marketing platform, accounting software, business analytics tools)
- Participation in an exhibit, festival, vendor showcase or artist residency
- Presentations or participation at a conference or symposium

- Enrollment in professional development workshops or the engagement of consultants or coaches to build administrative and business skills
- Development of promotional materials such as electronic media kits or creation of highresolution images

AWARD AMOUNTS

Applicants may request up to \$500. Award amounts will depend on applicant's usage for the funds and total funds available. No matching funds are required.

ELIGIBILITY

At the time of application, applicant must meet the following requirements:

- Have been enrolled in and completed CBCA's Advancing Creatives Intensive (ACI) 2024: Northern Colorado program on February 23-25, 2024.
- 18 years of age or older and a resident of Colorado.

CAREER ADVANCEMENT GRANTS DO NOT FUND

- Costs exclusively tied to regular, ongoing artistic creation.
 - These funds support business or career development, or creation of new artistic work that is directly tied to business or career advancement.
- Funding to offset applicant's regular salary or wages
 - Applicant should not include expenses to compensate for personal time spent on the project.
- Reimbursement of expenses paid prior to March 1, 2024.
- Reimbursement of Advancing Creatives Intensive tuition fee.

These Career Advancement Grants support a diverse array of creative work but if you are unsure if your project is eligible, please contact CBCA before applying. Contact: Lindsey Bell, Program & Events Coordinator, Ibell@cbca.org.

NUMBER OF AWARDS

Applicants may apply for only one Career Advancement Grant upon completion of the Advancing Creatives Intensive (ACI) program.

PAYMENT PROCESS

Awards payments will be processed and sent via check. Applicants will be required to submit a W-9 at time of Grant award notification in order for CBCA to process their check. It may take up to three weeks to process and receive the check after receiving notification of Grant award.

AWARD CRITERIA

While this Career Advancement Grant is designed for participants in CBCA's Advancing Creatives Intensive program, there is still a competitive review process to determine eligible projects and award amounts.

Career Impact (70%)

- Clear and specific business and career goals for arts/creative practice
- Connection between funding request and specific business and career goals

Budget (30%)

• Appropriateness of the costs associated with the proposed activity

• The purpose for which the awarded funds will be used

NARRATIVE

All applicants will respond to a set of questions about their project (see Appendix A in this document).

CAREER ADVANCEMENT AWARD APPLICATION QUESTIONS

NARRATIVE QUESTIONS

Career Impact:

- 1. Provide your "elevator pitch" for your creative work and proposed usage for these career advancement funds. (1,500 character limit)
- 2. Describe how your proposed usage of these funds will directly advance your arts business and/or creative career. (1,500 character limit)
- 3. What is your proposed timeline? (1,500 character limit)

Budget:

- 4. In a brief narrative description, please provide the total estimated costs and any other funding sources to support this endeavor. (1,500 character limit)
 - a. Provide itemized details on the "Fund Request Spreadsheet," submitted as an attachment (Form provided in Appendix B)

Certifications

Applicants must certify the following in their application:

- **Certification** that, if awarded a Career Advancement Grant, applicant will use it for the intended purpose indicated in their application; or notify CBCA immediately with an explanation of why that purpose has changed.
- Certification that the applicant will complete the Final Report by August 30, 2024.

Failure to submit any of the required attachments and certifications may be grounds for the rejection of the application and denial of funding.

FINAL REPORT

The Final Report is due no later than August 30, 2024 by 5:00 pm.

APPENDIX A – DETAILED USE OF FUNDS

- Purchase of equipment and materials to expand or improve an applicant's arts business and/or creative production
 - Requested equipment should not be a major start-up cost of doing business (i.e., a photographer requesting a camera).
 - Updating or upgrading equipment or software is eligible.
 - New equipment or materials for artistic creation that are directly connected to business goals, new consumer markets and career advancement. (i.e., musical equipment to go on tour, materials for applicant's first public art installation).
- Develop or upgrade technology related to business practices
 - Examples include online sales systems, website functionality, business analytics tools, social media management platform, online inventory platform, accounting or financial management software.
- Enroll in professional development workshops or engage consultants and coaches to grow specific administrative and business skills
- Develop promotional materials
 - Examples include professional headshot or artwork photos, graphic design fees, printing costs
- Participate in an exhibit, festival, vendor showcase or artist residency
 - Eligible: art supplies, registration, lodging expenses, airfare, booth rental
 - Ineligible: food/beverage expenses, companion expenses
- Present at a conference or symposium
 - Ineligible: food/beverage expenses, companion expenses
